
### THE NADCAP<sup>®</sup> PROGRAM

The Nadcap program is an industry-managed approach to conformity assessment that brings together technical experts from the aviation, defense, and space industries to establish requirements for accreditation, accredit suppliers and define operational program requirements. The program is universally recognized as the place for critical process experts to work together, putting quality above competition.

Managed by industry representatives for the benefit of all, the Nadcap program adds value to its stakeholders through its integral role of assuring product quality while reducing costs. In an industry where quality is mission-critical, we are proud to work closely with the best of the best for our mutual goal: safety throughout the aviation, defense, and space industries.

This results in a standardized approach to quality assurance and a reduction in redundant auditing because prime contractors, suppliers and government representatives have joined forces to develop a program that:

- **Establishes** stringent audit criteria that satisfy the requirements of all participants
- **Replaces** redundant auditing of Suppliers with one approved audit created by a consensus decision-making process in cooperation with members from the user community
- **Conducts** more in-depth, technically superior critical process audits
- Reduces costs through improved standardization
- **Uses** technically expert auditors to assure process familiarity
- **Provides** more frequent audits for primes, assuring quality standards are met



## THE HISTORY OF NADCAP®

In November 1989, the US Department of Defense/ Industry Equal Partners Conference recommended a consensus solution to the duplication of Supplier process control system audits. In 1990, the National Aerospace and Defense Contractors Accreditation Program (NADCAP) was established by key aerospace industry and US government representatives, administered by the not-for profit Performance Review Institute<sup>SM</sup> (PRI).

Prior to 1990, the major aerospace companies were auditing their own Suppliers for technical proficiency in areas such as non-destructive testing, welding, and heat treating. This meant a significant workload for the Subscribers, duplicate audits for the Suppliers, and auditors were often forced to become generalists to accommodate the workload.

As Nadcap grew internationally, it changed from an acronym (NADCAP) to a brand name (Nadcap). Today, Nadcap represents an unprecedented, cooperative industry effort to improve quality while reducing costs throughout the aviation, defense, and space industries.

Over the years, the Nadcap program has become an integral part of quality assurance throughout the global aerospace industry. Today, there are nearly 60 subscribing OEMs who participate in the program. More than 5,000 supplier audits are scheduled per year. To-date, approximately 4,700 Suppliers have earned in excess of 8,000 accreditations, while the program continues to expand and grow.

### SUPPLIERS BENEFIT FROM THE PROGRAM

Only the best companies in the global aviation, defense, and space supply-chain achieve Nadcap<sup>®</sup> accreditation. Nadcap audits are a rigorous technical assessment of compliance to customer requirements and industry standards, conducted by industry experts. By becoming accredited, Suppliers will:

#### Collaborate with Primes and peer suppliers to develop industry consensus audit criteria

### SUPPLIERS HAVE A VOICE.

Suppliers are a valued and integral part of the Nadcap<sup>®</sup> program as they provide additional guidance from the auditee perspective. To ensure their voices are heard, the program stakeholders meet three times a year. At these events, Suppliers have the opportunity to meet with the subscribing OEMs, and participate in Task Group breakout sessions.

There is a Task Group that represents each type of critical process accreditation of the Nadcap program. Each Task Group is comprised of subscribing OEM members who are technical experts. They develop audit criteria, approve Task Group Auditors, and define Task Group requirements. Suppliers are encouraged to attend and contribute to these productive Task Group meetings. Collaboration is key to the success of the Nadcap program.

### The Nadcap<sup>®</sup> Audit Process

The audit process typically begins with a notification from a prime manufacturer to the Supplier that they should attain accreditation, although some companies choose to pursue Nadcap accreditation without prompting from their customer.

The supplier then registers online in PRI EAN<sup>SM</sup>, the platform developed by the Performance Review Institute<sup>SM</sup> (PRI) that administers the Nadcap program, to schedule an audit. The PRI EAN platform is the core of the program, and source of all information regarding Nadcap Accreditation and audit details. Audits are booked 6-9 months in advance, allowing time to prepare. Preparation begins with a thorough review of the audit criteria and conducting a required self-audit to identify and correct any non-conformances prior to the Nadcap audit.

The assigned program-approved auditor will contact the auditee to set an opening meeting with all key stakeholders. At this meeting, the full audit scope will be reviewed with the team. The auditor then conducts the audit and will close each day with a review of any findings. At the end of the audit, a final review is presented to all key supplier stakeholders and the accreditation process is discussed.



After the auditor submits a report, the Supplier has an opportunity to respond to any nonconformances identified, and responses are reviewed by a Performance Review Institute Staff Engineer who is specialized in the specific critical manufacturing process. A Staff Engineer acts as a single point of contact between PRI and Suppliers, clarifying checklist questions, audit responses and anything else associated with the Nadcap special processes. They will guide the Supplier through the accreditation process to ensure successful completion.

Based upon the expectations of the participating Subscribers, when the Staff Engineer is satisfied that the root cause of all non-conformances has been identified and sustaining corrective action has been implemented, the entire report is submitted to the special process Task Group. This body of Nadcap Subscriber OEMs, who are also experts in the special process that has been audited, review the Staff Engineer's recommendations, and approve the audit for certification.
